Personal data that we process:

Musictrades.nl processes your personal data because you use our services and / or because you provide us your personal data. Below is an overview of the personal data we process:

- First and last name
- Address data
- Phone number
- E-mail address
- Location data
- Information about your activities on our website

- Internet browser and device type
- Bank account number

Special and / or sensitive personal data that we process:

Our website and / or service does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. However, we can not check if a visitor is older than 16. We encourage parents to be involved in the online activities of their children, in order to prevent data about children being collected without parental consent. If you are convinced that we have collected personal information about a minor without this consent, please contact us via ferry@musictrades.nl and we will delete the information.

For what purpose and on what basis we process personal data:

Musictrades.nl processes your personal data for the following purposes:

- Handling your payment
- Sending our newsletter and / or advertising brochure
- To be able to call or e-mail you if such is necessary to carry out our services
- inform you about changes to our services and products
- Give you the opportunity to create an account
- To deliver goods and services to you
- Musictrades.nl analyzes your behavior on the website in order to improve the website and to tailor the range of products and services to your preferences.

- Musictrades.nl also processes personal data if we are legally obliged to do so, such as information that we need for our tax return.

Automated decision-making:

Musictrades.nl does not take decisions based on automated processing on matters that can have (significant) consequences for people. These are decisions taken by computer programs or systems, without any handling by a person (for example an employee of Musictrades.nl).

Musictrades.nl uses the following computer programs or systems:

- Woocommerce, wordpress

How long we store personal data:

Musictrades.nl does not store your personal data for longer than is strictly necessary to realize the purposes for which your data is collected. We use the following retention periods for the following (categories) of personal data:

- (Category) personal data > 1 year

Sharing personal data with third parties:

Musictrades.nl provides exclusively to third parties and only if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

Cookies, or similar techniques, that we use:

Musictrades.nl uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. Musictrades.nl uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website work well and to optimize it. In addition, we place cookies that keep track of your browsing habits so that we can offer customized content and advertisements.

View, modify or delete data:

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Musictrades.nl and you have the right to data portability. This means that you can submit a request to us to send the personal information we have in your computer file to you or another organization mentioned by you. You can send a request for access, correction, deletion, data transfer of your personal data or request for cancellation of your consent or objection to the processing of your personal data to ferry@musictrades.nl. To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make sure that your passport photo in this copy, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) is black. This is to protect your privacy. We respond as quickly as possible, but within four weeks, at your request.

Musictrades.nl would also like to point out that you have the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.

How we protect personal data:

Musictrades.nl takes the protection of your data seriously and takes appropriate measures to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification.
